

**ACUSHNET BOARD OF SELECTMEN

**I. CALL TO ORDER
PLEDGE OF ALLEGIANCE**

Present: Selectman David Wojnar, Selectman Robert Hinckley, and Town Administrator James Kelley

Absent: Chairman Kevin Gaspar, Sr.

Selectman Hinckley welcomed the room to the meeting with the Board of Selectmen on December 1, 2023 at 11:00 AM EST. Selectman Hinckley asked for a motion to call the December 1, 2023, regular meeting of the Board of Selectmen to order. Selectman Wojnar motioned to call the meeting to order. Ms. Garrant explained what she did in the Town of Dartmouth and her responsibilities. She stated that she is happy to help the Town of Acushnet implement Invoice Cloud, at which Selectman Wojnar was very happy to do. Selectman Hinckley agreed with Selectman Wojnar and stated that he is excited to have Ms. Garrant as part of the team. Selectman Wojnar acknowledged Ms. Carla Mourao's contributions to the Town by holding the department together through all of the Interim Treasurer/Collectors.


