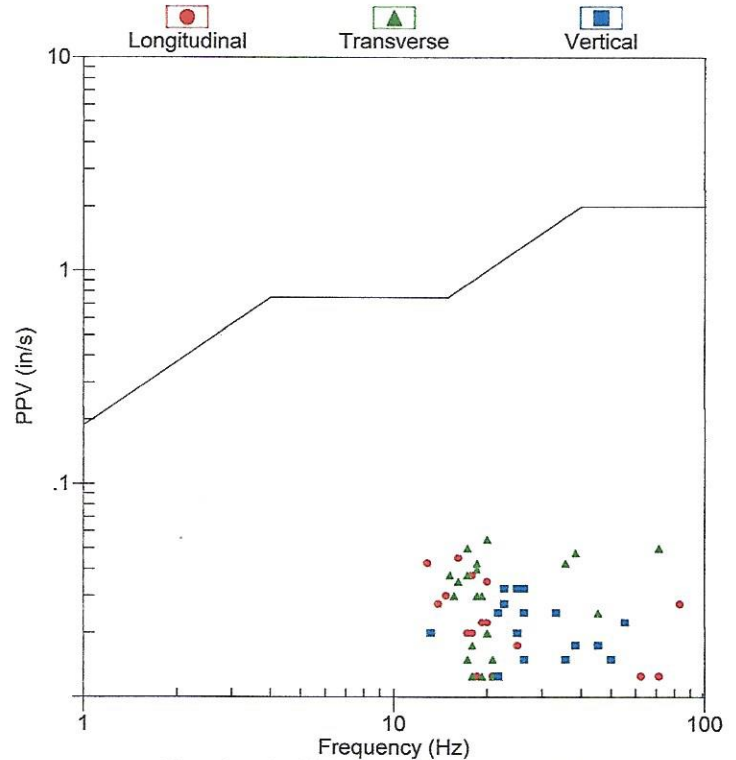

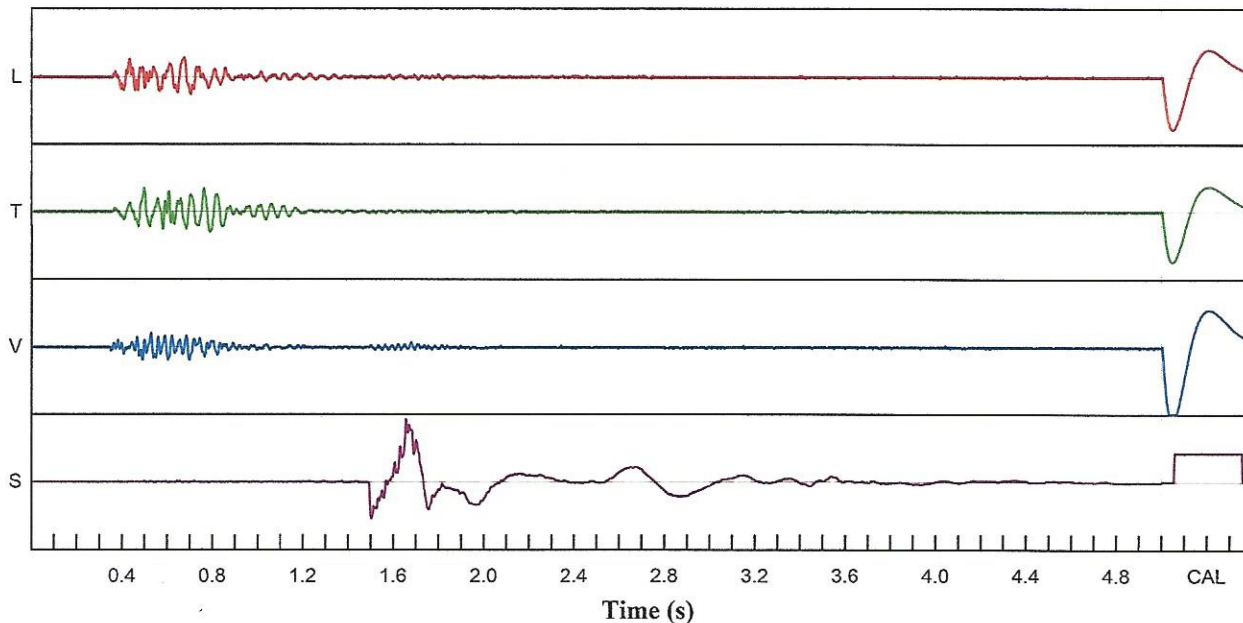


Zero Crossing Half-Wave Frequency Analysis
