6:10 pm Mr. Cabral made a motion to open meeting, Ms. Kelly 2<sup>nd</sup> the motion, all were in favor, motion passes.




Mrs. Begin has taken our Town's By-Law, Regulations & DEP Regs and suggest we combine on the permit as a reference to comply with; PM Control, the air regulations, air permit and storm water regs. Discussion ensued about an inspector needed for such inspections of the quarry, if Woodard & Curran are going to do the inspection for the Town they will only be looking specifically at the Air and Dust techniques at the quarry. More discussion ensued about operation times and noises levels at night, and about when inspections should be done at the quarry as part of their permit from the Town.


Mr. Correia will take all discussed at meeting and will combine as part of conditions on their permit and have all parties involved review and comment at needed for the next Soil Board meeting.
