REPORT OF THE SCHOOL COMMITTEE.

In presenting this annual report, the Committee have but few remarks or suggestions to offer.

Soon after the spring election the Committee organized, by the choice of Amos K. Haswell, Chairman, and Geo. P. Morse, Secretary.

Assignments for the supervision of the different schools were as follows:

Districts No. 1, 5, and 6 to Amos K. Haswell.
" " 4, 7, 8 and 9 to Jabez Wood.
" " 2 and 3 to Geo. P. Morse.

During the month of September our Chairman resigned his office. Consequently the Selectmen and remaining School Committee convened according to law to fill the vacancy, and elected Geo. H. Winchester. At the first meeting of the Committee at which Winchester was present, Jabez Wood was chosen Chairman.

It is well known that Jabez Wood has not, in consequence of his absence from town, visited the winter schools at all. And therefore our knowledge of the general proficiency of all the schools is somewhat limited.

We give below a brief account of each school, showing the attendance, &c., of each.

The winter terms are all now in session, hence their length is not reported—and their average is only to date.

DISTRICT No. 1.

Summer Term—Taught by Hope L. Ashley. Length of school 5 months; wages of teacher \$20 per month; whole number of scholars 22, average attendance 16.

Winter Term—Taught by Robie W. Keen. Wages of teacher \$22 per month; whole number of scholars 24, average attendance 16.

Prudential Committee, Reuben Peckham.

DISTRICT No. 2.

Summer Term—Taught by Lucy A. Ashley. Length of school —; wages of teacher —; whole number of scholars —; average attendance —.

Winter Term—Taught by Lucy A. Ashley. Wages of teacher \$23 per month; whole number of scholars 21, average attendance $16\frac{8}{11}$.

Prudential Committee, Sherman Ashley.

DISTRICT No. 3.

Summer Term—Taught by Angeline M. White 10 weeks and by Martha W. White 8 weeks. Length of school weeks; wages of teachers \$18 per month; whole number of scholars 36, average attendance $26\frac{1}{4}$.

Winter Term—Taught by Mary R. Hinkley. Teacher wages \$25 per month; whole number of scholars 38, average attendance $31\frac{1}{2}$.

DISTRICT No. 4.

Summer Term—Taught by Sarah Haswell. Length of school 5 months; wages of teacher \$20 per month; whole number of scholars 23, average attendance 18.31.

Winter Term—Taught by Sarah Haswell. Wages of teacher \$26 per month; whole number of scholars 24, average attendance 20.61.

Prudential Committee, J. R. Davis.

DISTRICT No. 5.

Summer Term—Taught by Georgianna Horton. Length of school $4\frac{1}{2}$ months; wages of teacher \$17 per month; whole number of scholars 24, average attendance 17.

Winter Term—Taught by Hattie Pease 6 weeks, and the remainder by Augusta C. Harvey. Wages of teachers \$32 per month; whole number of scholars 23, average attendance 18.

DISTRICT No. 6.

Summer Term—Taught by Sophia W. Horton. Length of school $4\frac{1}{2}$ months; wages of teacher \$20 per month; whole number of scholars 29, average attendance 22.

Winter Term—Taught by Sophia W. Horton. Wages of teacher \$25 per month; whole number of scholars 25, average attendance 21.

Prudential Committee, P. Crandon.

DISTRICT No. 7.

Summer Term—Taught $2\frac{1}{2}$ months by Fanny C. Grinnell, at \$20 per month; and by Paulina Wilson and Sarah E. Grinnell 2 months at \$24 per month. Length of school $4\frac{1}{2}$ months; whole number of scholars 36, average attendance 28.

Winter Term—Taught by Benjamin T. Wilber. Wages of teacher \$35 per month; whole number of scholars 37, average attendance $22\frac{9}{9}$.

Prudential Committee, Wm. Brownell.

DISTRICT No. 8.

Summer Term—Taught by Serena F. Wood. Length of school 5 months; teacher's wages \$25 per month; whole number of scholars 32, average attendance $24\frac{1}{5}$.

Winter Term—Taught 2 months by Serena F. Wood at \$30 per month; the remainder of the term by Sarah E.

Grinnell at \$28 per month; whole number of scholars 33, average attendance 25 $\frac{2}{3}$.

DISTRICT No. 9.

Summer Term—Taught by Mary J. Wing. Length of school 4 $\frac{1}{2}$ months; wages of teacher \$19 per month; whole number of scholars 19, average attendance 13.72.

Winter Term—Taught by Mary J. Wing. Wages of teacher \$22 per month; whole number of scholars 15, average attendance 12.

This district has not chosen a Prudential Committee—its affairs have been under the care of the School Committee.

In the following, we exhibit the number of children in each district, as returned by the Assessors 1st of May 1865, and the apportionment of money to the several districts.

The Committee are of the opinion that the schools, taken as a whole through the year, have made commendable progress. Some of them have been *very* good. But we think it an unfavorable fact that there have been so many changes of teachers in some of the districts; as in Nos. 3, 5 and

7, the two former having had three, and the latter four different teachers during the year. In one instance the teacher was caused to leave by sickness, in another, by the offer of a more lucrative position elsewhere—and in another case the teacher was asked to resign, having failed to meet the expectations of the committee, or the approval of a majority of the district.

In two or three cases there has been wanting on the part of the teachers, that *interest* and *energy* which is calculated to awaken in the pupils the spirit of *diligence* and *ambition* that we are ever gratified to see.

In one instance the teacher has evinced a commendable degree of interest and zeal; but owing in part to inexperience and a want of cool, deliberate forethought, and partially, we think, to a lack of sympathy and cooperation on the part of the parents, uniform good order and respect for the teacher have failed to appear.

Good government is one of the first requisites in a teacher. However much of intellectual attainments they may possess, no school can be well *taught* that is not well governed. Good order, good manners, and good morals, are equally essential. And the teacher that would secure that controlling influence that leads to these high attainments must secure the love and respect of their pupils.

Whilst we would not claim perfection for our teachers, we wish here "once and again" to suggest to the parents the propriety of forming an early acquaintance with your teachers by visiting the school-room, or by a cordial greeting in the street and elsewhere, and by making the schools a topic of conversation, *manifesting* an interest in them which shall encourage the teacher to make the greatest efforts for the improvement of their charge.

Every parent may exert a *great* influence, *favorable* or *unfavorable*—therefore as you value the best good of your children, be slow to credit every report, be *sure* they are correct before you are unfavorably influenced by them.

We would suggest, too, that it is most *unwise* for parents

and others in the districts to be influenced in their views of teachers' labors, by old prejudices.

We believe in one instance at least, the teacher and school have been *very* much injured, by the prejudices that existed before the teacher went into the school. We have no doubt there would have been good success in that school, had the teacher come into it a stranger. We think said teacher well qualified for the place.
