REPORT OF THE SCHOOL COMMITTEE.

At the end of another school year, as is customary, your committee submit a report of their proceedings.

As soon as practicable after town meeting, the committee organized by choosing Jonathan Taber as chairman, and Richard Davis, Jr., as secretary.

APPROPRIATIONS.

Amount raised for support of schools, Received from state fund, \$2,000.00 159.58

There has been a school in each house during the year, as was the general wish expressed at town meeting; and with the scholars scattered as they are, and the school-houses situated as they are; at present it is impossible to give satisfaction in any other way. But the time may not be far distant when the town shall see fit to build one or more new school-houses, and at the same time locate them in such a manner that one or more schools may be dispensed with; but till then you cannot suspend any one of them without depriving more or less scholars of rights to which they are entitled.

BISBEE'S - (Formerly No. 1.) -

This school has been taught during the year by Martha W. White.

Summer term. Length of school 5 months; whole number of scholars 15; average attendance 11; wages of teacher \$25 per month.

Winter term. Length of school 3 months; whole number of scholars 16; average attendance 13; wages of teacher \$28 per month.

COUNTY ROAD - (Formerly No. 2.)

Summer term. The first part of the term was taught by Heppie Davis, the remainder by Myra S. Rounseville. Length of school 5 months; whole number of scholars 16; average attendance 13; wages of teachers \$25 per month.

Winter term: taught by Myra S. Rounseville. Length of school 3 months; whole number of scholars 16; average attendance 10; wages of teacher \$28 per month.

WHELDEN'S - (Formerly No. 3.)

Summer term: taught by Hattie S. Clapp. Length of school 5 months; whole number of scholars 21; average attendance 17; wages of teacher \$28 per month.

Winter term: taught by Lucy M. Cobb. Length of school 3 months; whole number of scholars 28; average attendance 24; wages of teacher \$30 per month.

ACUSHNET - (Formerly No. 4.)

This school has been taught during the year by Charles L. Russell.

Summer term. Length of school 5 months; whole number of scholars 22; average attendance 14; wages of teacher \$30 per month.

Winter term. Length of school 3 months; whole number of scholars 23; average attendance 19; wages of teacher \$36 per month.

LONG PLAIN - (Formerly No. 5.)

Summer term: taught by Carrie S. Sanford. Length of school 5 months; whole number of scholars 11; average attendance 9; wages of teacher \$25 per month.

Winter term: taught by Phebe A. Gerrish. Length of school 3 months; whole number of scholars 16; average attendance 11; wages of teacher \$28 per month.

HAMMETT'S - (Formerly No. 6.)

This school has been taught during the year by Eliza F. Elliott.

Summer term. Length of school 5 months; whole number of scholars 31; average attendance 20; wages of teacher \$25 per month.

Winter term. Length of school 3 months; whole number of scholars 29; average attendance 23; wages of teacher \$30 per month.

PERRY HILL.

Summer term: taught by Lydia P. Robinson. Length of school 5 months; whole number of scholars 29; average attendance 19; wages of teacher \$25 per month.

Winter term: taught by Walter Taber. Length of school 3 months; whole number of scholars 31; average attendance 21; wages of teacher \$30 per month.

PACKARD'S.

Summer term: taught by Martha M. Ellis. Length of school 5 months; whole number of scholars 30; average attendance 18; wages of teacher \$25 per month.

Winter term: taught by Mary E. Snow. Length of school 3 months; whole number of scholars 26; average attendance 20; wages of teacher \$27 per month.

WING'S - (Formerly No. 9.)

Summer term: taught by J. C. Allen. Length of school 6 months; whole number of scholars 12; average attendance 8; wages of teacher for 2½ months \$22, for 3½ months \$25.

Winter term: taught by L. P. Robinson. Length of school 2 months; whole number of scholars 12; average attendance 9; wages of teacher \$25 per month.

We do not propose to enter into any flattering eulogy or severe and personal criticisms of the teachers in the different schools, but suffice it to say that on the whole general satisfaction has been manifested. Scholars and teachers have worked together, and the result has been one with which we may well congratulate ourselves. They have had some difficulties to contend with, as they always have had, and probably ever will, such as tardiness and irregular attendance; but matters like these, which are beyond our control, we of necessity pass by, feeling it nevertheless our duty to encourage the children, and the parents for their children, that they improve what advantages there are while they have time and opportunity, for these years once passed are forever passed beyond the power of any to recall. May the future show marks of renewed interest and responsibility in these things, that our children may grow up with an education that will be a comfort to themselves, and make them ornaments to society and a blessing to the community at large.
