REPORT OF THE INSPECTOR OF CATTLE.

FOR THE YEAR 1901.

Your Inspector received notice from the State Board late in September, that all cattle, sheep and swine, and all places where they were kept, should be thoroughly inspected and reported before Nov. 15, and all animals infected with tuberculosis were to be quarantined. Especial care was to be taken to notice the distance from the barn or stable to the well or drinking place. There was a very perceptible improvement in the care of the barns and cattle, and with two or three exceptions, where the stock was too closely crowded, and ventilation illegal, everything was in excellent condition. It has seemed to your Inspector, and doubtless to many others, there was *too much* required in the matter of inspecting, but as these fearful diseases, so fatal to the human family, as well as the animal kingdom, are increasing so rapidly, and in the past has been demonstrated, that much of this contagion is communicated by animals to the human race ; and as your Inspector has noticed how much more intelligent owners of cattle are becoming regarding these diseases, and taking much more care and trouble to prevent them, it does not seem so important as when first made necessary by law. There were 160 barns and about 500 cattle and 300 hogs inspected and examined. No trace of tuberculosis was found.

The places illegally sufficient for the stock have been remedied.

DISTRICT SUPERINTENDENT'S REPORT.

TO THE SCHOOL COMMITTEE OF ACUSHNET:

In accordance with your regulations I have the honor of submitting to you my first report as Superintendent of the schools under your charge. Although my work began in September, the statistics appended to this report cover the previous winter and spring terms.

With one exception, I found new teachers in every school. This involved making practically a new start, and has been unfortunate in many respects. Yet in nearly all your schools there have been pleasing signs of progress, and much honest and efficient work has been done by both teachers and pupils.

The strong and weak points in your school system have been studied during the past months. Necessarily there will always be opportunities for improvement, and our aim will be to secure as many of these improvements as are feasible. The desired results, however, cannot be obtained by any single set of forces. The combined efforts of officers and teachers are seriously handicapped unless they are constantly supplemented by the closer and intelligent interest of the parents and citizens.

One of the vital needs of our schools is the co-operation of the parents, in securing more regular attendance. Irregular attendance and tardiness are most serious obstacles to progress. An absent day here and a week there, entails upon the pupil and the whole school, a loss that cannot be regained. It means that a boy or girl gets out of joint with the class and sadly out of harmony with the work. I wish something might be said through you to those comparatively few parents

who, on account of the irregularity of their children, are making the work in one or two of your schools very unsatisfactory. To be sure there are justifiable cases of absence, but the vital question is to reduce the *unnecessary* cases.

On account of the large enrollment at the primary school, it was necessary to send the 3rd grade up stairs, thus making six grades, with 47 pupils, in the grammar school.

This involved the employment of an assistant, but it has been very difficult both for teachers and pupils to have two recitations going on simultaneously in the same room. However, all have shown a commendable spirit in working under these conditions. The need for more room here will demand your serious attention before the opening of another school year.

By way of suggestion I would say, that instead of spending from \$100 to \$200 for rent or \$500 for temporary relief, it might be practical and, in the long run, more economical, to widen the building in such a way as to provide four rooms, three of which are already needed.

At Long Plain the numbers are not as large as formerly, but it is hoped that the enrollment next year will be large enough to warrant the continuation of the two schools.

A glance at the financial statement shows that there has had to be a curtailment in the purchase of books and supplies. There will be an urgent need for increased expenditure in this line during the coming year.

It is a fact that our public schools are costing more and more every year, but by means of the strictest economy and an *unusual* dividend from the State Fund, your schools have been supported within the appropriation.

For the support of nothing else does the tax payer yield his money more gladly than for the public schools.

Gov. Crane, in his last inaugural address, said, "Upon the public schools more than upon any other public agency depends the welfare of the commonwealth. Their contribution

to the welfare justifies the large sums annually expended upon them."

The cost for high school tuition this year is large, but I believe it is smaller than the expense of anything like a satisfactory local high school, which, even with inexperienced teachers and inefficient equipment would cost from \$1000 to \$1500 a year, and in addition it would be necessary to pay the tuition elsewhere for the last two years of the high school course. At present a local high school would not afford any financial relief, while the advantages would be inferior.

The growing demand of the cities for grade teachers is making the problem of rural schools more perplexing. The rural school especially depends upon a good teacher, but the successful teacher is always looking for promotion to the graded positions. However, the most of your schools have been fortunate in this respect, and there has been a distinct advancement in the interest of the pupils and the kind of work that is being done.

I have appreciated the constant interest of the teachers, and the cordial co-operation of your committee. With the continued support of all those who are interested in the schools, I believe that steady progress is possible.
