CORRESPONDENCE

Letter from Community Nurse and Home Care Statistics for January 2024. Mr. Medeiros made a motion to place on file, Chairman Davignon seconded the motion, all were in favor, motion carries.

DISCUSSION

Public Health Excellence Training Hub Lead Trainer, Derek Macedo. - Agent Correia gave the board an overall explanation of who he is and what the training hub will do. Chairman Davignon made a motion to have Derek come to the next full board meeting to meet with him, Mr. Medeiros seconded the motion, all were in favor, motion carries.

Letter from Fredette Engineering regarding 352 Main Street is requesting a waiver to keep tight tank after upgrade of SAS or future use seeing the tank is structurally sound. Discussion ensued about how some businesses require a tight tank such as a beauty salon or dentist. Mr. Fredette explained this is a stable H2O tank and feels it is an asset to the property by leaving in place seeing the property is for sale. Mr. Medeiros made a motion to allow the tight tank to remain in place with covers welded tight and if no use to the tank within one year from today then the tank will be filled with sand and the covers to be welded shut, Chairman Davignon seconded the motion, all were in favor, motion carries 2-0.

Charon Associates for 6 Pine Street to add a septic tank for one (1) bedroom apartment to existing SAS. Discussion ensued about this being a three (3) bedroom house and the house will be brought to a two (2) bedroom home and adding an apartment with a one (1) bedroom keeping the house three (3) bedrooms only with no increase to the flow. Chairman Davignon made a motion to approve the plan with conditions: that an architect plan drawing showing existing conditions and proposed floor plan and when the remodel happens then Agent Correia will do a walk-thru making sure the layout is correct keeping the property three (3) bedrooms only and ZBA approval is needed prior to issuing a permit to install the tank, Mr. Medeiros seconded the motion, all were in favor, motion carries. Chairman Davignon is requesting we put in letter form so that way this letter can also be handed to ZBA.
